# Evacuation Procedures

## Bomb threat procedures – all venues

- If you find an unattended package/ bag etc. do not touch it. Inform Harrogate Convention Centre Management and Event Organisers.
- Do not activate fire alarms.
- If the threat is made by telephone the same procedure is to be followed.

## Fire evacuation drill/procedure

- If you discover a fire or suspect there is a fire, for whatever reason (i.e. you see smoke):
- RAISE THE ALARM – operate the nearest glass fronted fire alarm call point (located near fire exits, main doors, linkways etc.) – this will sound the alarms and result in attendance by the Fire Brigade.
- You must inform a member of Convention Centre staff of the area the fire is in.
- The sounding of loud alarms/sirens indicates a fire alarm.
- In The Royal Hall there is a taped voice message to advise of the evacuation.
- Only if you have been trained to do so are you to attack the fire with the equipment provided – and only if there is no immediate danger to yourself.
- Be aware of the type of fire you are fighting, i.e. electrical fires must only be fought with green/black/blue extinguishers, or those displaying the appropriate markings.

## Evacuation

- If you should hear the alarm, evacuate immediately by the nearest exit and make your way to the appropriate assembly point
- Exhibitors are advised not to try to remove their goods from the halls or indeed remain with them because they may have significant value.
- You will be informed of the situation at your assembly point.
- Permission to re-enter the halls may only be given by the Fire Officer in charge.

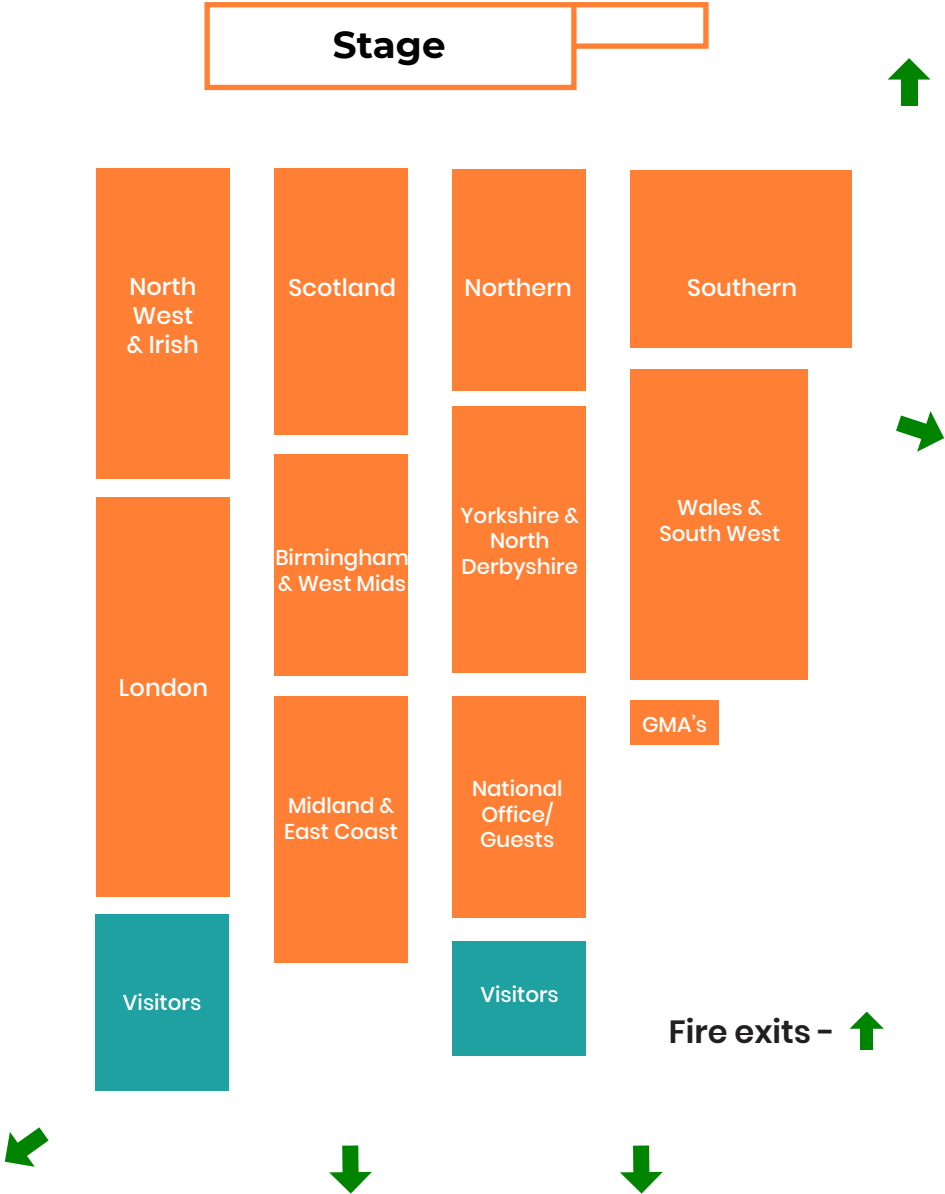

## UNDERSTANDING THE INSECURE ECONOMY AND HOW TO FIGHT BACK

Britain is at serious risk of turning back the clock on our working lives to resemble those of the dockers in the Victorian era, waiting for a day's work while a handful of people at the very top hoard all the profits.

We invite you to join CLASS as we discuss our 2022 report - a collaboration with Autonomy Think Tank; *The Insecure Economy: Measuring and Understanding the Contemporary Labour Market* - which found that employment insecurity has increased across practically every industry since 2005.

This report shows that job insecurity has risen across nearly every industry in the last two decades, characterised by zero-hours contracts, low pay and weakened trade union rights. We urgently need to create new laws, like a £15 minimum wage and better protections for trade unions so people can come together and demand better for themselves. The government must create an economic system which can provide for everyone, because if you work for a living you ought to earn a good living.

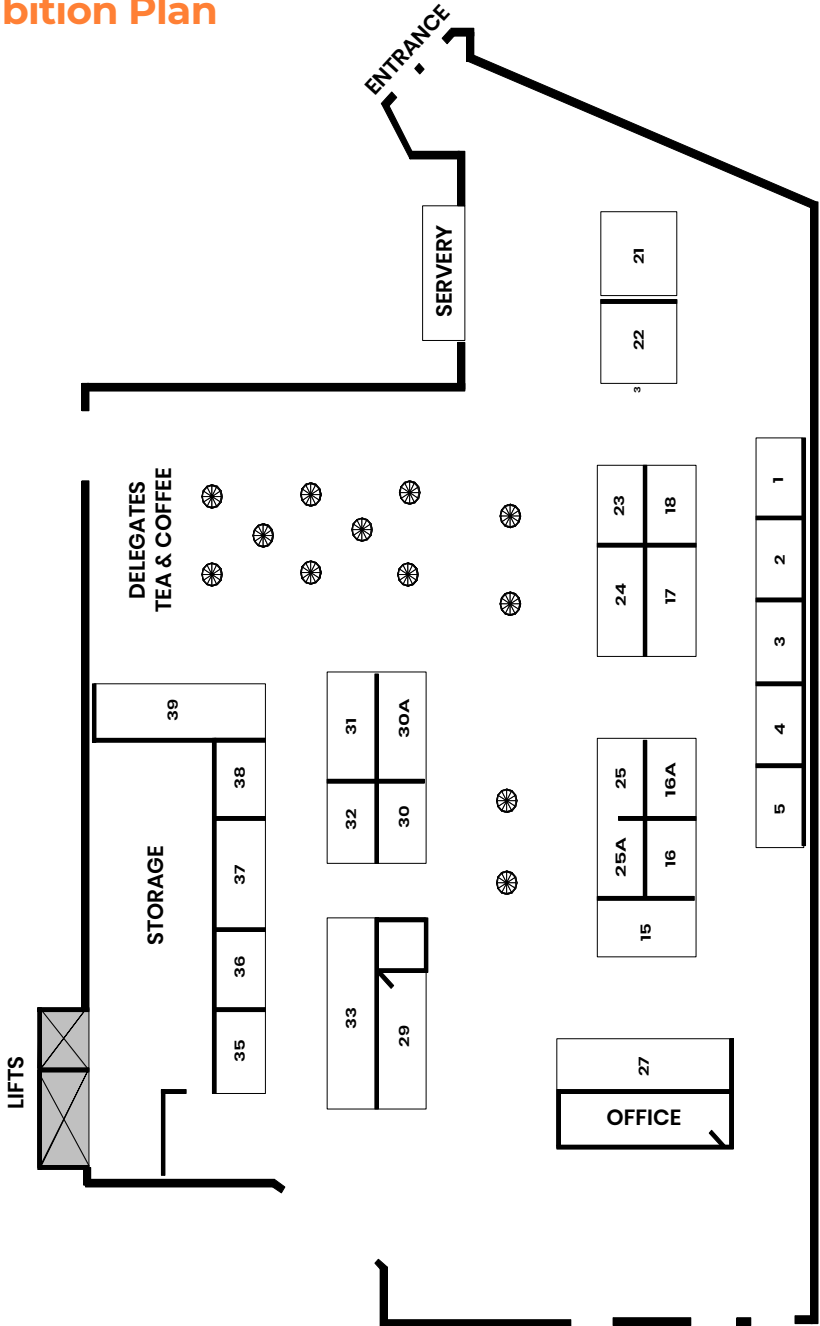

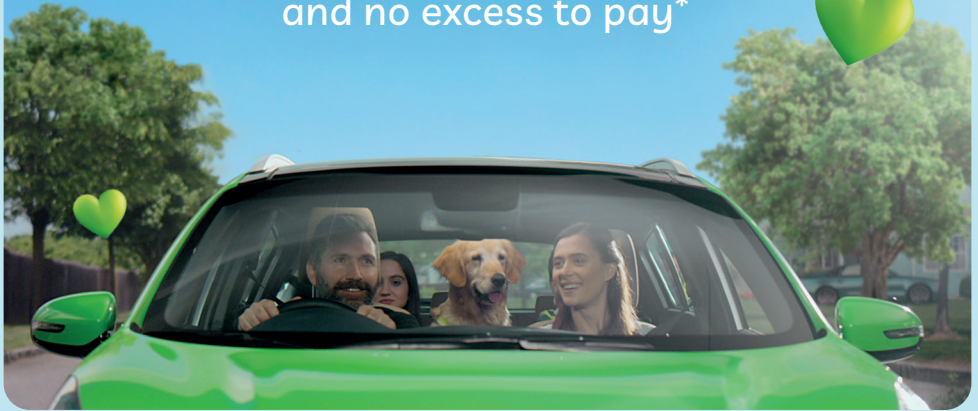
