

However we have to admit this is still early days and we are learning lessons all the time in our attempts to reach out to workers and organise there. There is not a one size fits all approach as we encourage organising activity that is fresh, innovative and challenges the perceived norms of organising more traditional and established fields of employment.

As well as producing educational resources we deliver programmes of direct anti-racism education with over 50,000 young people and more than 6,000 adults every year.

SRtRC also organise high profile anti-racism events with professional sporting clubs and a national School Competition.

The SRtRC competition is the largest equalities themed competition in England.







Now, Trump has put sanctions on Venezuela, with the aim of starving the country of financing, and even threatened military intervention. Republican senator Marco Rubio has also recently invoked the possibility of a military coup in the country.

VSC is a broad-based organisation for Venezuela's self-determination and supporting dialogue as a way for the country to move forward, and works to build links between Britain and Venezuela's trade unions. The GMB and 16 national unions are affiliated.

War on Want

Poverty is not an accident – poverty is political. Decisions made by politicians or companies in rich countries can mean life or death for people. War on Want tackles the root causes of global poverty, and challenges those institutions that perpetuate that poverty.

Together with our trade union affiliates, we have campaigned against CETA - a free trade deal negotiated in secret between the EU and Canada. War on Want is fighting to end the exploitation of workers in the supply chains for UK high street shops. We stand in solidarity with workers across the world who face intimidation and retaliation for organising into trade unions. Today, migrant workers in the UK face racism. abuse and exploitation, and it is no coincidence that many are employed on precarious contracts and constantly face the threat of losing their job.

War on Want works in partnership with trade unions and inspirational groups in rural communities, factories, sweatshops or conflict zones around the world. We believe the best way to tackle poverty is to support those organisations that are best placed to find their own solutions for social change.



WASPI - Women Against State Pension Inequality

No Notice - Significant changes to the age we receive our state pension have been imposed upon us with a lack of appropriate notification, with little or no notice and much faster than we were promised - some of us have been hit by more than one increase. As a result, hundreds of thousands of us are suffering financial hardship, with not enough time to re-plan for our retirement.

No Letter - Women are telling us that they can't believe their retirement age has increased by 4, 5 or 6 years and they never got a letter!!!!

No Pension - Securing work is proving impossible and zero contract hours or Job Seekers' Allowance is the only alternative with many others having to depend on relatives and partners

Work Stress

Stress can be a Killer - it can take people off work for long periods of time with heavy costs to the individual and their family, the business also to the economy. The Mental Health of all workers is a matter of priority for all managers and employers. Health & Safety Laws require that workers are not injured by work. This Government claims that most workplaces are 'safe workplaces', but a Mind Survey showed the opposite:

- 19% of all workers take a day off sick because of stress, with 90% giving different reasons for their absence.
- 10% of workers have resigned because of Stress and 25% are thinking about it.
- 20% of workers cannot tell their boss if they feel stressed at work.
- 50% of managers want to do more to improve mental wellbeing in their workplace, but 46% report it is not a workplace priority.
