THOUSANDS of Birmingham schoolchildren were given an extra hour in bed as furious public sector workers stayed at home or hit the picket line in a national protest over pensions.

Schools, libraries, nurseries and job centres closed their doors on Tuesday in a bid to defend the pensions of council staff against proposed government changes.

The most burning issue for the 100,000 Midlands employees was the withdrawal of the right of scheme members to retire at the age of 60.

One of the largest rallies held throughout the city took place in front of the Council House in Victoria Square where hundreds of demonstrators resoundingly asserted their beliefs.

A vocalist on stage led the crowds in a sing-song while flags and giant foam gloves were enthusiastically waved.

Bimla Kaur, aged 52, a teaching assistant took the day off work from Cherry Orchard school in Handsworth Wood.

"My pension is very important to me and I want to stand up for my rights. Who else will defend them if you can't?" asked the grandmother.

"Many of our members are infu-



riated because after decades of riated because after decades of working in the same job they expected the security of a comfortable pension. When they discovered at the last minute this was not the case they were understandably annoyed."

Social worker Jean Woodall who works at Selly Oak and the Children's hospital added: "It is a just cause but we are getting a lot of criticism from the general public who think we should work until we are 70.

"A lot of the workers are under-A lot of the workers are underpaid and are looking forward to their pensions. Besides, it will be silly going to work with a zimmer frame," said the 57-year-old.





The ship called regularly at Chatham, Sheerness, Herne Bay and Southend. She was powered by a diagonal compound steam engine, originally coal burning but converted to oil in 1938. This engine is still intact and will be restored.
